NEW IN 2019-2020: *FACTS Tuition Management Company* will be handling tuition payments for our school. *FACTS* offers several payment options using either ACH (automatic draft) or credit card payments. Using ACH allows you to establish a payment draft date convenient for you. ***FACTS* charges a processing fee of \$50 annually for 3-10 payments or \$20 annually for 1-2 payments.** If you choose not to establish an account with *FACTS*, you will need to pay tuition in full, cash or check, by August 18, 2019. We will also accept two payments, in cash or check, with the first half (50%) due August 18, 2019 and the second half due January 18, 2020. There will be a **late fee** of \$25 assessed for past due tuition payments.

HOME AND SCHOOL ASSOCIATION (HSA) FAMILY POINT SYSTEM:

All families are encouraged to participate in the HSA Family Point System. By fully participating in this system through working and selling, you are eligible for the HSA discounted tuition rate. Partial participation will require a family to pay the additional tuition owed to the school by the required due date.

AFTER SCHOOL CARE: 3:30 – 5:30 p.m. daily on school days - ***does not include early release days***

Cost per Month: \$100 Full-time (August and December prorated \$50 FT or \$25 PT)
\$50 Part-time (5 hours or less per week)
\$25 late fee if not picked up by 5:30 p.m.

A *drop-in* must be approved by Administration and only for an emergency, \$10/child
